



Research Question

• RQ: What are the human rights violations experienced by the drivers partnering with platform-based taxi aggregators?

Methodology and Analysis


- Qualitative research methodology
- Studied four strikes (March 2017, January 2018, June 2018, and October 2018, where the drivers working with the cab aggregators participated in Chennai).
- Strikes covered in detail in *"Thozhilalar Koodam"*, a media website dedicated to the cause of the working class.
- We studied the report very carefully, identified and then classified every event/experience/incident to one of the human rights violation through consensus

1.	Violation of survival rights	Longer hours of work bringing about health problems and keeping them away from family	"Rs 1000-Rs 1500 per day, they would have to spend almost 14 hours on the road".
		Increase in debt rather than income	"Onions are priced at Rs. 50 per kilo today and we are driving our cab for Rs. 6 per km. How does this make sense? Do customers not wonder how we eat and live? We may as well change our work from Call Taxi to Free Taxi".

2.	Violation of membership rights	Drivers, although labelled as "partners", could not approach management	They feel unwelcome whenever they visit to one of the company's offices, which they liken to a <i>"prison complex"</i> with an <i>"intimidating atmosphere"</i> .
		Discrimination between drivers in distribution of opportunities for work	"the drivers of leased cars [get] longer rides, while car owners are given shorter rides"

3.	Violation of empowerment rights	"Mysterious" technology allocating rides, fares, and payments.	[Every significant activity in the business like] "payment, ride allocation, etc. are decided unilaterally by the company using technology"
		No control on the number of rides one is allocated and the places of duties.	"I waited hoping that I will be assigned the last trip [to meet the target post which an incentive would be paid] but it never came and the deadline was over".
		Apprehensive on feedback from customers that affects their earning	drivers are apprehensive that customers may rate them thoughtlessly, which may affect the number of rides assigned to them.

Absence of protection rights

1. No regulation on slashing of tariffs to be charged.

2. No regulation on increase of commission to be paid to the platform organization.

3. No minimum wage guaranteed for the work done

4. No legislations permitting the organizing of the drivers working with cab aggregators.

5. No protection from being "mis-informed" by the organization.

Contribution to theory

- Validated the previous findings
- Provided an overarching framework of human rights to aggregate past and future research
- Argued a theoretical link between counterproductive work behavior and human rights violations based on social exchange theory.

Contribution to practice

- Provide a legal definition to platform workers and recognize them as employees⁵
- Platform organization may design a growth plan for their drivers.

^{5.} The Parliament of India recently reformed the labor laws in interest of ease of doing business. It classified 29 existing Central labor laws to four labor codes – The Wage Code (2019); The Industrial Relations Code (2020); the Occupational Safety, Health and Working Conditions Code (2020); and the Code on Social Security (2020). Only the Code on Social Security (2020) includes the phrase "platform work". It is defined as "a work arrangement outside of a traditional employer employee relationship in which organisations or individuals use an online platform to access other organisations or individuals to solve specific problems or to provide specific services or any such other activities". The Code on Social Security (2020) assures that the Central Government would formulate and notify social security schemes specific to platform workers. Specifically, the schemes would cover the worker's life and disability, would provide insurance against accidents, assure health and maternity benefits (including crèche), as well as provide for old age protection. Platform workers are still excluded from other codes, especially from the Code of Wages and The Industrial Relations Code. This jeopardizes their right to organize and to secure a minimum wage.
